

### I Recipe from the True Crew



#### **INGREDIENTS:**

2 cans evaporated milk

1 heaping tbs margarine

3 heaping tbs corn starch

Water

2 eggs

1 cup sugar

1 tbs vanilla

#### **DIRECTIONS:**

In a large pot add the evaporated milk, two cans of water and margarine. Place on stove to heat until margarine is melted.

While that is heating, in a medium size bowl whisk together sugar, corn starch, eggs and vanilla.

When the margarine is melted: (DO NOT REMOVE FROM HEAT) Slowly whisk in the sugar, starch and egg mixture. Continue stirring until thick. Place in a large glass bowl. Cover and refrigerate for at least 4 hours.

Great served with fresh fruit (blueberries, strawberries, peaches, bananas).

For Chocolate Pudding add chocolate syrup (not powder) to taste.
